Special Meeting Minutes

CALL TO ORDER

Commissioner Messing called the special meeting to order at 6:00 PM. In attendance were Commissioner Shaun Nye, Executive Director Jerry Williams, Attorney Peter Ruffatto of Chmelik, Sitkin & Davis, Auditor Joseph DaBell, Candidate Carol Tripp, and Candidate Kenneth McEwan.

APPROVAL OF AGENDA

Commissioner Messing motioned to approve the agenda as written. Commissioner Nye seconded the motion. The motion passed.

- "Is there any conflict of interest in working in this position?"
- "What would your availability for the position be?"
