

## Is it registered?

June 30<sup>th</sup> marked the official expiration of all Washington registration tags for water vessels. All boaters in the marina

have the responsibility to keep current registration on their vessels. Please make sure you are visiting your boat and placing the new 2023 sticker on your vessel. This is a must!



## Are you sure about Insurance?

All boaters are responsible to maintain current and adequate insurance on any vessel moored in the Port's facilities. (Please review the Ports Rules and Regulations for required coverage)

Now is a great time to check your records and review your insurance policy. Following an incident is the absolute worst time to discover that your policy has changed and is not what you really thought it was, or that your expiration date slipped by you and now you have a fiscal disaster on your hands! Every year there are cases where an owner finds out too late that something changed in their policy and "That" is no longer covered.

# **Electronic Payment Kiosk**

The Port will be installing 2 electronic pay kiosks. One at the boat ramp and one at the East Breakwater. These "Iron Rangers" will provide the ability to pay for boat launching and guest moorage without having to come to the office and eliminate the clumsy wet envelope situation! The final arrangements are being made and we expect to be ordering these units very soon.

### **Financial workshop**

The next Finance Workshop will be held in-person at the Port Annex building located at 9756 Ogle Rd NE. Anyone wishing to submit questions may do so using the Port provided form. This form is available on the home page of Port's website, or you can contact the Port office and we can provide you with a printed or electronic copy directly.

The work on the North Breakwater has been completed. Several sections of chain were replace using Kinter links. New anodes were placed on all chains. We expect this to be a lasting repair for several years

Our main pier has several piles that are in need of attention. The Port has entered contract with a local contractor to make these repairs. Our contractor reports that the materials have been arriving as expected it is estimated that work will begin in early August.
