INFORMATION, STAFF AND COMMITTEE REPORTS

a. Manager's Report – Robyn Dally presented the Manger's Report. We have the Hunters Association of Puget Sound coming on Friday with four to five boats. We have a wedding in Upper Park and in the Pavilion on Saturday. We have Pumpkin Palooza on the 20th. We have the Navy Yacht Club in from the 27th through the 29th, Haunted Harbor on the 27th, and an Upper Park Rental on the 28th. For slips we have 20, 20 to 24's open, most likely those won't rent out until next boating season. We have fourteen others open, and we will be making additional calls this week. Kat has been calling all our tenants to remind them about their payments if we have not received them. She's also been making an effort to call anyone who's 30 days or 45 days late. We've seen some good success with collecting some of the outstanding rents. The kiosk covers came in. Maintenance is currently working on assembling those and figuring out how they are going to attach those. 2 1/2 weeks ago the roof on this building started leaking, Maintenance guys jumped on it, have sealed it and have resurfaced most of it. Currently deck maintenance has been going on, and they have done some maintenance on the pump out boat.

NEW BUSINESS

- 1. Brownsville Yacht Club leasehold tax. Paul brought forward that DOR has granted the Yacht Club an exemption to the leasehold excise tax going back to 2019. Stated that he had brought this to the Ports' attention in April. The YC is requesting the Port refunds the leasehold tax that has already been paid for. The YC also received confirmation from the Department of Revenue that yes, they are extending the exemption again for this year. Jan states there is one statement that needs to be added to issue reimbursement. Then amend 15 quarters. Once we submit that to the state, they will decide on it, they will remit the money to the port, and then the port would immediately remit it to the Yacht Club.
- 2. Haunted Harbor a request for Commission action here from Brownsville Yacht Club, Haunted Harbor. The requested action is approval of allowable expense for promotional hosting event Haunted Harbor to be held October 27th, 2023. The club also promotes these visitors to donate canned goods for the local furniture food line. Finance Fiscal Impact report will provide one free night of mortgage up to \$1500 for the vessel owners who decorate their boat and actively participate in this event. It will allow the use of pavilion use the pavilion and one of the Port's outdoor heaters to the hosting club as a staging area free of charge. The port also provides personal flotation devices, flip jackets for the non-adult visitors to be used during the event free of charge, which the Port has in its store reaction. The Commission is asked to consider a motion authorizing the concession related to mortgage and the use of port property identified in this request for action supporting the Haunted Harbor. The commission is concerned about the gifting of public funds. The yacht club will be responsible for the LET for the slips. Commissioner Messing motioned to approve the resolution. Commissioner Nye seconded the motion.
